Who is a child?

A child is someone under the age of 18.

What is safeguarding?

- **Providing help** and **support** to meet the needs of children as soon as problems emerge.
- **Protecting** children from maltreatment, whether that is within or outside the home, including online.
- **Preventing** impairment of children's mental and physical health or development.
- **Ensuring** that children grow up in circumstances consistent with the of safe and effective care.
- **Promoting** the upbringing of children with their birth parents, or otherwise their family network through a kinship care arrangement, whenever possible and where this is in the best interests of the children.
- **Taking action** to enable all children to have the best outcomes in line with the outcomes set out in the Children's Social Care National Framework.

Safeguarding Reminders

Prevent - Report any incidences involving extremism or radicalisation immediately to your DSL. **Female Genital Mutilation (FGM)** - Report immediately to your DSL if you believe a child is at risk Report to your DSL and to the Police (if you are in a teaching role) if you believe a child has had FGM. **Online Safety** - Remain vigilant of any concerns. relating to online safety and report to your DSL. Be aware of the content, contact, communication and commerce that children may be exposed to. **Child-on-child abuse** - This can be physical, verbal or sexual and can be online or offline.

What is abuse?

Abuse is a form of maltreatment where a child is harmed or not protected from harm - physical, emotional, neglect and sexual.

How do I safeguard children?

- **RECOGNISE:** Be Professionally Curious – actively looking as well as listening to signs of harm
- **RESPOND:** Never promise to keep it secret
- **REPORT:** Always share information to the Designated Safeguarding Team as soon as you have a concern
- **RECORD:** Create a written record of your concern and include any actions taken
- **REFLECT:** We all have a role to play to safeguard children
